DONATION: 30 Chairs for 30 Euros for Yaoui

In 2018 and 2019, we used most of the donations to build a Leisure and Meeting Center on the grounds of the Yaoui school. This could be realized through the generous donations of the campaign "Protestant Church on Pützchens Market" (see also article "Yaoui on Pützchens Market" in this newsletter). Here are the pictures of the construction of the Leisure Center:



What's missing are 30 Chairs for the interior.

1 Chair costs 30 Euros. Each donor of 30 Euros receives a picture with his name on the Chair donated by him.

If someone wants to donate or knows someone who wants to donate, they can do it now.

One chair cost 30 Euros.

If a non-member also wants to have a picture of his Chair, then this must necessarily communicate his E-Mail-Address. For club members this is not necessary.

NOTE: For donations under 100 Euros, the account statement is a donation receipt!

I would like to point out that it takes some time to transfer the money and produce the chairs. At the last donation campaign with the School Desks for the school in Yaoui, it took a little more than 1 year (see also Newsletter No. 33) until the pictures were sent to us.

For information: Donation Receipts

The legislator has provided that in the case of donations under 200 Euros, the bank statement is considered a donation receipt. The association Yaoui e.V. automatically issues a donation receipt if the amount exceeds 100 Euros. Under or even equal to 100 Euros applies to Yaoui e.V. the account statement as a donation receipt.

As we have stated in the board, this regulation works in all federal states.

If somebody should have difficulties with amounts below 100 Euro in his tax declaration, you are welcome to contact the board.
